- Others (subject to availability and at the discretion of SRI-CONNECT and InterAxS Global)

Beyond the 12 selected companies, other companies can purchase the core communications support activities for a price of GBP 3,500 + VAT.

Companies can supplement the core programme by paying for enhanced services including:
